Electronic bids must be submitted to the Office of Ishma Rural Municipality, Ishma Rajasthal, Gulmi, Nepal through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 08-04-2018 (2074/12/25) 12:00. Bids received after this deadline will be rejected. (PE:- Office of Ishma Rural Municipality, Ishma Rajasthal, Gulmi).
7. The bids will be opened in the presence of Bidders representatives who choose to attend at 08-04-2018 (2074/12/25) 13:00 hours at the office of Office of Ishma Rural Municipality, Ishma Rajasthal, Gulmi, Nepal
8. Bids must be valid for a period of 90 of days after bid opening and must be accompanied by a scanned copy of the bid security issued by "A" class commercial banks approved by Nepal Rastra Bank conforming to standard format as specified in bid document in pdf format, amounting to a minimum of 230000.00 NRs which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. If a Bidder does not manufacture or produce the Goods and it offers to supply the desired goods shall submit the Manufacturer's Authorization or letter of Authorized Dealer of desired goods using the form included in Section IV, Bidding forms to demonstrate that it has been duly authorized by the manufacturer or producer of the Goods to supply these Goods for the desired contract in Nepal and take care of the warranty provided thereafter.
11. Minimum average annual construction turnover of NRs 9 Millions (average of best three years for last five years) as mentioned in Bidding Document.
12. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
